ELIGIBILITY REQUIREMENTS

 - Company Profile and organization structure with the CV of 3 key personnel with Professional Certificates.
 - Evidence of Financial Capability (Reference letter from reputable Bank capable and willing to provide line of credit for project execution, if required);
 - Current Tax Clearance Certificate of the Company and Two Directors for the last three (3) years (2023, 2024 and 2025);
 - Evidence of Technical Capacity (list of equipment, staffing etc);
 - Possession of experience as a Prime Contractor in at least two (2) projects of similar nature and complexity with verifiable letters of contracts award and certificates of job completion within the last five (5)years from 2023;
 - Exact verifiable location and full Address/Contact, Telephone numbers and Email address of the authorized representation;
 - Evidence of technical partnership (Manufacturer’s authorization where necessary);
 - In case of Joint Ventures, the company shall provide evidence of the Joint Venture Agreement executed by all parties in the Joint Venture;
 - Performance Bond issued by Bank or Certified Insurance Company.
 - Prospective Bidders should procure a Bidding Document at Ikeja Local Government Secretariat.
